Once we were assembled and in one place, we

- 1) Checked in (having said 'Hi' and caught up generally and reflected on previous week 1st July) and Howard shared some thoughts on the rule of life from Psalm 119 v 33-40 (Hebrew letter He)

General Comments
We read about the impact of the Gospel;

- a) The conversion of other cultures (1) Simon the Sorcerer Acts 8 v 9-25 Simon was clearly a charlatan who wanted to buy the impact of signs and wonders. The Early Church was clearly moving in the gifts of the Spirit and impacting on the street culture of popularist vendors.
- b) The conversion of other cultures (2) The Ethiopian Official Acts 8 v 26-40 The Ethiopian official by contrast was a high ranking financier whom Phillip met at a watering point on the desert road. The Early Church was clearly

moving in the gifts of the Spirit and impacting on higher educated culture of foreign travellers

c) The conversion of other cultures (3) A Leading Pharisee (Saul) Acts 9 v 1-19

Saul was a Pharisee of Pharisees and God even used a murderer who was complicit in the first martyrdom as the person who was to open up the Gentile world to the Gospel. We noted the bravery and care of the prophet Ananias in being open to the Spirit in welcoming Saul.
